INTRODUCTION

Recently, we have seen an explosive expansion of international trade with an increasing importance of multimodal transport and logistics services. With the globalization and trade liberalization we have seen considerable developments in the type and quality of transport and logistics services and infrastructure. The growth of containerization introduced the concept of Multimodal Transport shifting the cargo delivery system from “port-to-port” to “door-to-door” and the increasing importance of the Multimodal Transport Operator (MTO), who, as a single transport operator, will be responsible for the movement of goods interconnecting different links or modes of transport -air, sea and land- into one complete process that ensures an efficient and cost-effective door-to door movement of goods.

The conference, organised by IMMTA with the cooperation of Grupo Stier and The Las Palmas Port Authority, will provide the opportunity to examine the role of the Logistics Operator with the different services involved, including insurance for the operators and cargo. The Conference will also discuss the international regulation of liability for multimodal transport with special focus on the Rotterdam Rules (the new United Nations Convention 2008).

Finally, Las Palmas Port Authority will illustrate to us the role of the port of Las Palmas as a logistic platform situated in the Atlantic Ocean.
